

Jesus said, "The son got up and went to his father. But while he was still a long way off, his father saw him and was filled with compassion for him; he ran to his son, threw his arms around him and kissed him" (Luke 15:20).

He was homeless, smelly, and almost starving to death. But the worst thing was that he knew it was all his fault. He thought his father was cruel and overbearing; there were too many rules. He wanted freedom. He wanted to have fun, but his father was all about responsibility and hard work. So, he asked for his share of the inheritance. He didn't care about the farm; he just wanted the money. As soon as he got it, he left. He could finally do what he wanted to do.

But it didn't take long and all that money was gone partying is expensive. Those he thought were his friends left as soon as he ran out of money. He was all alone and miserable. He had two choices, and neither seemed pleasant. He could continue as he was and hope he could scrape enough together each day so that he wouldn't starve to death, or he could go back home.

He headed for home. He was prepared to grovel, to ask to be just a hired hand on his father's farm. But he didn't get the opportunity to do much groveling. As soon as his father saw him coming, he ran out to meet him. He hugged and kissed him, and gave orders for a huge celebration in his honor. The rebellious son had expected a cool reception. He had expected an "I told you so." Instead he got what he knew he didn't deserve: a joyous welcome home.

You and I are that young man who rebelled against his father. We have all rebelled against our heavenly Father. We have considered him to be cruel and overbearing and having too many rules—someone who doesn't want us to have any fun. We have all separated ourselves from him and broken his commandments. Our consciences tell us that he is angry, that we deserve whatever pain or suf-

fering comes our way. Could our heavenly Father still love us? Could he still welcome us to his eternal home in heaven?

Jesus' story about the disobedient son in Luke 15:11 -24 is a short story that speaks volumes for our lives. It assures us of God's love and our heavenly home. #### **OUR MISSION**

To use Life & Family Issues As Bridges To Convey The Love of God & To Share The Message Of Salvation Through Christ.

This organization educates people on what God's Word has to say about the value and sanctity of human life. The intent is to mobilize Christians to make God-pleasing decisions about life and family issues. We focus attention on many issues such as: abortion, infertility, birth control, post-abortion syndrome, assisted suicide, and euthanasia.

#### **OUR BEGINNING**

When the U.S. Supreme Court legalized abortion nationally on January 22, 1973, members of St. John's Evangelical Lutheran Church in Libertyville, Illinois, saw the need to do something. Working with their pastor and with members from area Wisconsin Evangelical Lutheran Synod (WELS) congregations, they opened the first WELS Lutherans for Life pregnancy counseling center. As time passed, more and more independent centers sprouted up around the country until 1983 when they united to form the national organization that existed as WELS Lutherans for Life. In 1999, the name was changed to Christian Life Resources. Incorporated.

#### **OUR AFFILIATION WITH THE WELS**

Christian Life Resources subjects itself to the doctrine and practice of the Wisconsin Evangelical Lutheran Synod, but it is not supervised or funded by the WELS budget or its administrators.

### OUR GROWTH

Today, our organization consists of pregnancy care centers across the United States. These centers are visited by approximately 11,000 clients each year. Our network of pregnancy care affiliates offer a warm heart, listening ear and helping hand along with a wealth of information to guide those involved in an unexpected life choice.

Christian Life Resources founded and supports New Beginnings – A Home for Mothers, located in Milwaukee, Wisconsin. This program began in 1993 in response to the needs of single mothers and their newborns by providing residence and assistance in spiritual, academic, and vocational concerns.



# **CENTRAL AFRICAN MEDICAL MISSION**

Lutheran Mobile Clinic (LMC)—Malawi—January 2019

In our newsletters we often discuss LMC. As Lutherans we have had conversations about how we show God's love by providing primary health care to people in the rural areas of Malawi. We have also talked about the clinics and how our primary focus is on mothers and young children while also providing outpatient services and HIV counseling. But what is seldom discussed and what makes LMC unique is the fact that we are mobile.

Unlike our sister clinic in Mwembezhi in Zambia which is static, at LMC all services and supplies are brought to the people. On an average day, 10-12 medical staff make their journey to clinic sites by using the ambulance for transport. The current villages are Suzi, Thunga, Msambo, and Mwalaulomwe—all of which are within an hour's drive from Lilongwe. Early each clinic day, all supplies, equipment, medications, and in the case of Thunga Village—additional water, are loaded onto the Ambulance for the day's journey. At the end of the day everything is offloaded, and supplies are restocked ready for tomorrow's clinic.

The vehicles not only perform the mundane tasks of taking staff and equipment to the clinics but are also equipped with marking, lights and sirens for emergency transportation of patients to the general hospital in Lilongwe. Recently a very pregnant woman came to clinic and was found to be in labor, she was immediately put in the ambulance and was transported (with lights and sirens) to the Chiwamba health center. The baby was delivered in the back of the ambulance three minutes after we arrived.

Our vehicle of choice is the Toyota Land Cruiser. The version we use here in Malawi bears no resemblance to

the Land Cruiser that is seen on the roads in the United States. Ours are tough, ruggedized, 4 wheel drive vehicles that can reliably carry up to 13 people plus a roof rack loaded with equipment and supplies.

Currently we have two ambulances, the older one is 8 years old and is getting to the stage where repairs become more numerous and costly. The newer vehicle is 5 years old. Every week over 900 patients depend on LMC to show up. Cancelling clinic due to vehicle repairs is not acceptable. The reliability of these vehicles is paramount as we simply cannot have them in the workshop for any extended period of time. For that reason, we replace them on a five-year cycle before maintenance becomes a problem. This year we will replace the older vehicle. A new Land Cruiser is not cheap. A vehicle delivered to Malawi costs a little under \$40,000.

It is hard to overstate the importance of these vehicles to the medical mission here in Malawi. Simply put, they put the "mobile" in Lutheran Mobile Clinic and are vital to our operations as blood pressure cuffs and malaria medications. As our Central African Medical Mission team continues the effort to raise the funds for the new ambulance we ask for your prayers to bless this work and your support to allow us to continue to show God's love to the people of Malawi.
