More Than Mere Roses


This year in our monthly articles we are considering favorite verses from the Bible. This month's favorite Bible verse is: John 3:16.

At this time each year, I can't help but look forward to the next year and in this case, the next decade. The thoughts of something "new" – new beginnings, new time to use better, new, new, new – and it is exciting. At the same time, I can't help but look back and reflect on the previous year – what was accomplished, what was learned, what created joy. I get to do this in my personal and professional life. As a member of The Central Africa Medical Mission, I also reflect on what 2019 meant for CAMM and what plans we have for 2020.

2019 was another unbelievable year for CAMM. God's blessings for the work that we do shouldn't ever surprise us, but regularly we sit at our meetings in happy surprise and humbled awe on how God does. Here are a few highlights of the year:

*In Mwembezhi, Zambia: Alisad Banda, Administrator, and Jackson Kalekwa, Clinical Officer, continue to handle the day to day operations at the almost 60 year old clinic. Under the guidance of these 2 men, the clinic continues to serve over 10,000 patients a year. We are blessed that both of these men are our brothers in faith and are able to let God's light shine in their interactions with the staff, patients and many others.

*Gary and Beth Evans settled into their second year in Malawi. The Evans continue to be a wonderful blessing that God has given CAMM. Their experience, guidance and dedication to the mission have enabled us to be more collaborative between our Malawi Operations and our Zambia Operations.

*Beth has focused on working with the staff to improve how we triage our patients at each clinic site in Malawi, signing them up for training sessions for their own professional development and empowering them to bring their suggestions forward.

*Gary has focused on the grounds of our clinic sites in both Zambia and Malawi. In Zambia, we are readying the "new" clinic building for move-in, so we can create more space in the old clinic building. In Malawi, we have made major improvements at our Mwalaulomwe clinic building, including a new procedure room and are continuing to work on the plan to improve Msambo and Thunga.

*We were blessed with many donations from our supporters – monetary and otherwise, including pill bottles, baby hats and blankets, sunscreen and more. (Please make sure to reach out to Cheryl Valus, Contact Woman Coordinator, for a list of special projects that are available.)

*There are so many more blessings that CAMM has received in 2019 – most of which have been highlighted in the monthly letters and on our Facebook and web pages.

As I sit in awe of what God has allowed us to do in 2019, I can't help but look forward and be excited about 2020. Here are some of the things that we are looking forward to:

- *Continuing to repair our clinic sites and boreholes in Malawi
- *Repairing the old clinic building in Zambia
- *Continued collaboration with our teams in Malawi and Zambia and possibly other organizations
- *Hiring a few new staff members
- *Helping others go to college with the Althea Sauer Scholarship and more much more!

Plus, as we approach 2021, we will be celebrating God's Grace for the 60 years of operations in Zambia for the Central Africa Medical Mission. We will focus on all that God has guided us to do in our first 60 years and prepare for the next 60 years. Please keep your eyes open for all of the different projects that we will be highlighting in 2020 – 2021! With 2019 wrapping up, our prayer for you is that God continues to bless you as He has blessed CAMM.

ENVELOPE EXPLANATION

At the congregational meeting last month, a brief explanation concerning our offering envelopes was given. This explanation was given in the hopes to clarify the purpose and function of our offering envelopes—especially the three pictured to the right.

In 2019, the decision was made to combine all our offerings into one account. This means that offerings given in all envelopes go into the same account. From this account our Capital Improvements—including the mortgage payments—as well as our Congregational Mission Offerings are paid. So why continue with the envelopes pictured to the right?

The fact that the "Special Mission Offering" envelope appeared in the envelope box in 2020 was an oversight. It was not intended to be in there.

The council decided to keep the "Designated Offering for Capital Improvement Fund" envelope in the envelope box for 2020. The reason for this was to help members remember that even though all our offerings were being placed into one account, we still have the responsibility of mortgage payments on a monthly basis. All offerings in these envelopes are directed to the General Fund. This envelope will be removed in 2021.

The special offering envelopes (like Easter, Christmas, Lent, etc.) will continue to remain in the offering boxes into the future. This is so that individual members may have the opportunity—after prayerful consideration and if they are so moved—to give offerings over and above their regular offerings at these special services. These offerings are also placed into the General Fund.


LIBRARY CORNER

CALL TO ORDER

The purpose for this would be so that information for the congregational meeting can get into the hands of members a week prior to the meeting so they can be prepared and informed of what will/might be discussed.

- The congregation voted to accept the 2020 budget of \$211,040.18. MSC (copies can be found in gathering areas)
- The congregation voted to support the cost of the International Youth Rally as follows. The congregation will pay the total cost of transportation (minus gas), full cost of the rally (\$375) for 3 chaperones, and \$200 for each child. \$100 will be given to each lady for the women retreat. There will be roughly \$1,000 left in the budget for all other conferences throughout the year for a total of \$5,500. MSC

New Business

- The congregation voted to amend the Church Constitution for the addition of a deaconess within the Elder Committee. The wording shall be as follows: "The Elder Committee shall consist of three to five members including the chairman, who shall be appointed by the church council. The chairman will be a member of the Council. The remaining member shall be appointed by the committee chairman, including a deaconess."
- The congregation voted to allow all pastors of the congregation to have 3 weeks (Sundays) of vacation after 10 years serving in the ministry.
- Kirk Goetzka and Rick Treptow were both elected to the church council. Ballots were tallied by Garrett Jessie and Dave Spaude. We thank them for their willingness to serve, and we thank Grady Severson and Jerry Kirchman for their years of service on the council.
- Individual positions within the church council will be decided at the next council meeting.
